Criterion, the elements of contract award criteria	<p>The selection of the most favorable bid will be executed using the criterion "LOWEST OFFERED PRICE".</p> <p>If there are two or more bids with the same offered price, the contract will be awarded to the bidder offering a longer warranty period for the application software.</p> <p>If there are two or more bids with the same offered price, and the same offered warranty period for the application software, the contract will be awarded to the bidder who wins it in a draw. The Contracting Authority shall inform in writing all tenderers who have submitted bids about the date on which the draw will take place. The draw will include only those bids that have the same lowest offered price and the same offered warranty period. The Contracting Authority will perform the draw publicly, in the presence of the bidders, by placing the names of the bidders on separate papers of the same size and color and putting all those papers in a box, ball or other suitable object from which only one paper will be drawn. The bidder whose name is on the drawn paper will be awarded a contract. For bidders who do not attend this procedure, the Contracting Authority shall submit minutes from the draw.</p>

Reason for the extension of deadline for submission of bids	Modification of tender documentation
Manner of submission of bids and deadline for submission of bids	<p>Bids shall be considered timely if they are received by the Contracting Authority no later than 17 July 2019, by 12.30 pm.</p> <p>The bidder submits the bid directly or by mail in a closed envelope or box, closed in such a way that it can be certain that it is being opened for the first time at the opening procedure. On the back of the envelope or the box it is necessary to indicate the name and address of the bidder, together with the telephone number of the contact person. In case a bid is submitted by a group of bidders, it must be indicated on the envelope that it is a group of bidders and the names and addresses of all participants in the joint offer must also be indicated. The bid is to be delivered to the following address: Ministry of Finance, Belgrade, 20 Kneza Miloša Str., with an indication on the envelope, or box "BID FOR PUBLIC PROCUREMENT OF GOODS – PROCUREMENT OF A CENTRALIZED PLATFORM FOR SENDING, RECEIVING, MANAGING AND STORING ELECTRONIC INVOICES OF LEGAL ENTITIES AND ENTREPRENEURS, PP 9/2019".</p> <p>Untimely shall be considered a bid that has not been received by the Contracting Authority until the indicated date and time. Upon completion of the public opening of tenders, the Contracting Authority shall return to the bidders all untimely submitted bids, unopened, indicating that they have been submitted untimely.</p>
Place, time and manner of opening bids	Public opening of tenders will be held on the same day, after the expiration of the deadline for submission of bids, i.e. on 17 July 2019, at 1.00 pm in the premises of the Ministry of Finance, Belgrade, 20 Kneza Miloša Str., office number 235, in the presence of authorized representatives of interested bidders.
Conditions under which bidders' representatives may participate in the tender opening procedure	The present representatives of the bidders, prior to the public opening of tenders, must submit to the Public Procurement Commission an original copy of the written authorization for participation in the bid opening procedure.
Deadline for award decision	The decision on the award of a contract or the decision to suspend a procedure will be made within a period that can not be longer than 40 days from the day of opening the bids. The decision will be published on the Public Procurement Portal and on the website of the Contracting Authority within 3 days from the date of its adoption.
