The bidder whose name is on the drawn paper will be awarded the contract. For bidders who do not attend this procedure, the contracting authority shall submit a record of the drawing process.

In the case that the bid is submitted by a group of bidders, it should be indicated on the envelope that it is a group of bidders, and the names and addresses of all the participants in the group bid.
