Criterion, elements of the contract award criteria	<p>The selection of the most favourable bid will be made by applying the criterion "THE LOWEST PRICE OFFERED".</p> <p>If there are two or more bids with the same offered price, the contract will be awarded to the bidder who offered a longer warranty period for the application software - service bus platform.</p> <p>If there are two or more bids with the same offered price, with the same warranty period offered for the application software, the contract will be awarded to the bidder drawn by lot. The procuring entity shall notify all bidders who have submitted bids in writing of the date when the draw will take place. The draw will cover only those offers that have the same lowest offered price and the same offered warranty period for the application software. Drawing lots will be made by the Contracting Authority in public, in the presence of the bidders, by printing the names of the bidders on separate papers, which are the same size and colour and by putting all these papers in a box, ball or other suitable object from which only one paper will be drawn. The bidder whose name is on the drawn paper will be awarded a contract. The bidders who do not attend this procedure will be submitted the minutes of the drawing lots process by the procuring entity.</p>

Manner of submitting the bid and deadline for submitting the bid	<p>A timely bid is considered to have been received by the Contracting Authority no later than July 10, 2020 by 11:00 AM.</p> <p>The bidder submits the bid directly or by mail in a sealed envelope or box, closed in such a way that when opening the bids it can be determined with certainty that it is opened for the first time. The name and address of the bidder, with the telephone number of the contact person, must be stated on the back of the envelope or on the box. In case the bid is submitted by a group of bidders, the envelope must indicate that it is a group of bidders and state the names and addresses of all participants in the joint bid. The bid should be submitted to the address: Ministry of Finance, Belgrade, No. 20 Kneza Miloša St., with an indication on the envelope or box: „PUBLIC PROCUREMENT OF SERVICES - SERVICE BUS PLATFORM WITH ALL COMPONENTS FOR INTEGRATION WITH OTHER WORKING ENVIRONMENTS, LICENSES, HARDWARE AND IMPLEMENTATION, JN 5/2020 - DO NOT OPEN ”.</p> <p>A bid that has not been received by the Purchaser by the specified date and time will be considered untimely. Upon completion of the public bid opening procedure, the procuring entity shall return to the bidders, unopened, all untimely submitted bids, with an indication that they were submitted late.</p>
Place, time and manner of opening bids	<p>Public opening of bids will be done on the same day after the deadline for submission of bids, i.e. on July 10, 2020, at 11.30 am on the premises of the Ministry of Finance, Belgrade, Kneza Miloša No. 20, Office No. 238, in the presence of authorized representatives of interested bidders.</p> <p>After the opening and review of the received bid, if the bid meets all the requirements of this tender documentation, the negotiation procedure will begin.</p>
Conditions under which the representatives of the bidders may participate in the bid opening procedure	The present representatives of the bidders, before the beginning of the public opening of bids, must submit to the Public Procurement Commission the original copy of the written authorization for participation in the bid opening procedure.
Deadline for decision making	The decision on awarding the contract or the decision on termination of the procedure will be made within a period that cannot be longer than 40 days from the day of opening of bids. The decision will be published on the Public Procurement Portal and on the website of the Purchaser within three days from the day of its adoption.
