Manner of submitting the bid and the deadline for bid submissions	<b>The bid is considered to be timely if it is received by the contracting authority no later than by 12 AM, on November 15th, 2019.</b> The bid is submitted directly at the address or by mail in a closed envelope or a box, sealed in such a way that, when opening it, it can be determined with certainty that it has been opened for the first time. On the back of the envelope or box, it is necessary to write the name and address of the bidder, with a telephone number of the contact person. The bid is to be submitted to the following address: Republic of Serbia, Ministry of Finance, Belgrade, Kneza Miloša 20, for office 238, with an indication on the envelope or box: “The development of a platform for data consolidation and business reporting within the Ministry of Finance and

	<p>related administrations, JN P 3/2019 – DO NOT OPEN“.</p> <p>If the bid is not received by the contracting authority by the said date and time, it shall not be considered as timely. Upon the completion of the public opening of tenders, the contracting authority will return to the bidders all the unopened, untimely submitted bids, indicating that they have been submitted in an untimely manner.</p>
Place, time and manner of opening of bids	<p><b>Public opening of bids will be held on the same day that the deadline for submission of bids expires, i.e. November 15th, 2019, at 12,30 AM, on the premises of the Ministry of Finance, Belgrad, Kneza Miloša 20, office number 238, with the presence of the authorized representatives of the interested bidders.</b></p> <p>After the bid has been opened and reviewed, if the bid meets all the requirements of this Tender Documentation, the negotiation process will be initiated.</p>
Conditions under which representatives of bidders can participate in the opening of bids	<p>The representative of bidders, must before the beginning of the public opening of bids, submit to the Public Procurement Commission the written authorization for the participation in the process of opening bids and the authorization to negotiate, which is certified and signed by the bidder's legal representative. Also, the authorized representative of the bidder must on this occasion have a seal, in order to validate the bid.</p>
Deadline for the adoption of the decision	<p>The decision on awarding the framework contract or on stopping the procedure will be reached within a deadline that cannot be longer than 40 (forty) days from the date of the opening of the bid. The decision will be published at the Public Procurement Portal and on the webpage of the contracting authority within three days from the adoption of a decision.</p>
