Manner of submission of bids and deadline for submission of bids	The bid shall be deemed timely if it is received by the contracting authority no later than 11.00 am on 21 June 2019. The bidder shall submit the bid directly or by mail in a closed envelope or box, closed in such a way that it can be certain that it is being opened for the first time at the moment of opening the bids. On the back of the envelope or on the box it is necessary to indicate the name and address of the bidder, with the telephone number of the contact person. In case a bid

	<p>is submitted by a group of bidders, it must be indicated on the envelope, and the names and addresses of all participants in the joint offer must be indicated as well. Bids are to be submitted to the following address: Ministry of Finance, Belgrade, Kneza Miloša 20, with a note on the envelope or the box "BID FOR THE PUBLIC PROCUREMENT OF GOODS – DEVELOPMENT, IMPLEMENTATION AND MAINTENANCE OF THE INFORMATION SYSTEM OF THE REGISTER FOR THE UNIQUE RECORD OF USERS OF PUBLIC FUNDS WITH ACCOMPANYING COMPUTER EQUIPMENT AND LICENSES (EMPLOYEE REGISTER), PP 6/2019 – DO NOT OPEN"</p> <p>A bid will be considered untimely if it has not been received by the contracting authority until the indicated date and time. Upon completion of the public opening of tenders, the contracting authority shall return to the bidders all untimely submitted bids, unopened, indicating that they have been submitted untimely.</p>
Place, time and manner of opening the bids	The public opening of tenders will be held on the day of the expiration of the deadline for submission of bids, i.e. on 21 June 2019, at 11.30 am at the premises of the Ministry of Finance, Belgrade, 20 Kneza Milosa Street, office number 235, in the presence of authorized representatives of interested bidders.
Conditions under which the representatives of bidders can participate in the tender opening process	The present representatives of the bidders, prior to the public opening of tenders, must submit to the Public Procurement Commission an original of the written authorization for participation in the bidding procedure.
Deadline for adoption of decision	The decision on awarding the contract or the decision to suspend the procedure will be made within a period that can not be longer than 40 days from the day of opening the bids. The decision will be published on the Public Procurement Portal and on the contracting authority's website within 3 days from the date of adoption.
