

Pursuant to Article 43, paragraph 1 of the Customs Law („Official Gazette of the RS”, No. 95/18) and Article 43, paragraph 1 of the Government Law („Official Gazette of the RS”, No’s. 55/05, 71/05 – amm., 101/07, 65/08, 16/11, 68/12 - CC, 72/12, 7/14 - CC, 44/14 и 30/18 - other law),

The Government hereby enacts the following

D E C I S I O N ON SEASONAL CUSTOMS DUTY RATES ON THE IMPORT OF CERTAIN AGRICULTURAL PRODUCTS

1. The present Decision shall set the seasonal customs duty rates for the import of certain agricultural products, with time limits for their application.

2. In addition to the customs duty rates set out in the Customs Tariff Law („Official Gazette of the RS”, Nos. 62/05, 61/07, 5/09 and 95/18- other law), seasonal customs duty shall also be payable on the import of agricultural products, as follows:

3. When importing the agricultural products referred to point 1 of the present Decision and originating from the European Union countries, the companies and sole proprietors concerned shall present to the competent customs office the proof of preferential origin of goods.

4. The seasonal customs duty payable when importing certain agricultural products originating from the countries with which the Republic of Serbia has concluded free trade agreements shall be paid in accordance with the provisions of such agreements.

5. The validity of the Decision on Seasonal Customs Duty Rates on the Import of Certain Agricultural Products („Official Gazette of the RS”, No’s. 27/10, 97/11, 105/15 and 105/16) shall cease on date of beginning of applyment of the present Decision.

6. The present Decision shall come into force on 17th June 2019.
